dotHIV gemeinnütziger e.V. (hereafter: dotHIV) is constituted as a charitable association under German law. All members, board members and advisors to date come from Germany.

Membership status is not exclusive for German or European citizens, but with its legal jurisdiction in Germany and a deep integration in the German context of the HIV response (e.g. official partnership with Deutsche AIDS Hilfe), dotHIV will stay a German and European organization.

dotHIV is incorporated as a charitable association under the registration number VR 31092 of Amtsgericht Berlin/ Charlottenburg.

dotHIV is constituted as a charitable association under German law.

- The articles of association state and guarantee both the non-profit character and the charitable purpose of the organization.
- General operations are lead and executed by a management board of three (Carolin Silbernagl (Chair), Tobias Mölder (Vicechair), Philipp Kafkoulas).
- The members of the association (currently: 9) control the overall strategy of the organization and elect the board members at yearly general meetings.
- An advisory board with currently 3 individual members supports the work of the board and the members.

The general membership is defined and marked by the degree of operational involvement of members. The nine current members of dotHIV stem from very diverse backgrounds including communication, IT, law and the NGO sector. The unifying principle is the support of the mission and goals of dotHIV.

Members are kept informed and integrated through a weekly group call with agenda and meeting minutes.

dotHIV builds on vast voluntary engagement and pro-bono support by partnering organizations, especially its founding partners

dotHIV has filed an application for the string ".hiv" to ICANN's "New gTLD Program". The funding for the application and the preparation of registry services in value of 400.000€ stems from a private loan of dotHIV's fundraising body, the "TLD dotHIV registry GmbH" (see below).

Activities in line with the charitable purpose of dotHIV are financed through membership fees, individual or corporate donations, earnings from fundraising activities (e.g. <http://www.dothiv.org/deutsch-schlusselanhanger-fur-den-guten-zweck/>) and award money (e.g. Social Impact Enterprise Scholarship).

No funding from government agencies.

Private loan by the "TLD dotHIV registry GmbH": The GmbH is a German Limited Liability Company founded for the purpose of raising funds for dotHIV's application for the charitable Top-Level Domain ".hiv". The money stems

a) from private investors that we call "Social Business Angels", providing at least 25.000€ each, with 2.500€ invested in shares of the GmbH and 22.500€ as a private loan at 3% interest.

b) from a publicly supported technology loan.

Legal obligations make it difficult for a charitable association under German law to engage in comparable contracts. The GmbH is dotHIV's solution to raise the necessary investment while keeping the TLD application under the

roof and control of a charitable entity.

The GmbH is not represented in the governing bodies of the Charitable Association and does thereby not effectuate any sort of control or influence on dotHIV. In contrary, the Association itself holds 25,1% of shares of the GmbH and can thereby assure that the management of the fundraising entity goes in line with the overall goals and mission of the initiative.
