With offices in Washington DC (USA) and Geneva (Switzerland), it seeks to ensure the development, evolution and use of the Internet for the benefit of people throughout the world.

The Internet Society addresses issues that confront the future of the Internet and is the home for the groups responsible for Internet Infrastructure Standards, including the Internet Engineering Task Force (IETF) and the Internet Architecture Board (IAB).

The Internet Society does not only act as a global clearing house for information on the Internet and education, but also as a facilitator and coordinator of Internet-related initiatives around the world. For over fifteen years, ISOC has been developing international training programs for developing countries, which have played a vital role in the growth of Internet access, both in terms of quantity and quality.
