**The Judicial Association of Buenos Aires (Asociación Judicial Bonaerense, AJB) is made up of the Judicial Workers of Buenos Aires, Province of Buenos Aires, Argentina, which forms part of the Judicial Federation of Argentina, a labor union for all of the country's judicial workers. There are currently nearly 2,000 registered members who, in addition to being represented by the union, collaborate in voluntary activities involving the various topics of discussion of our organization. For this reason, based on debates and discussions regarding the impact of the issues that affect the information society and their link to judicial workers, a Center for Studies was created that is involved in issues concerning the impact of new technologies on the labor world, the ways in which our citizens interact with these technologies and the ways in which these technologies can be incorporated into our work in the justice field. We have been working on these issues from our Center for Studies for the past several years, participating in various activities such as the forum for public democratic communications [www.leydecomunicaciones.com.ar](http://www.leydecomunicaciones.com.ar); Internet Day, May 17 <http://www.diadeinternet.org>; discussion sessions regarding telecommuting; activities related to the debate on implementing IPV6 and its impact on the working world, etc.**

It should be noted that the Judicial Association of Buenos Aires (AJB) is made up of a Board of Directors composed of 8 primary members: Secretary General, Adjunct Secretary General, Secretary, Treasurer and 4 board members (2 primary and 2 substitutes). The election of the Board of Directors is conducted in a General Assembly. Meetings of the Board of Directors are conducted periodically for the purpose of reviewing and coordinating institutional projects. Currently, work committees have been formed with the goal of promoting worker participation in these activities.**
