*The structure of the Organisation includes a Board of Directors, which consists of 8 people. Regional participation throughout the country is ensured through Regional Delegates, which are directly appointed by the Board of Directors until the region is organised and can appoint its own Delegates. The Delegate must: organise the region, which involves creating a regional delegation structure with at least 8 (eight) members, and create sub-delegations throughout that region; inform the Board of Directors about the regional activities that are performed; inform about national activities that are conducted in the region; inform the Board of Directors about the requests and needs expressed by the Internet users covered by that Delegation; report the results of the election of Delegates to the Board of Directors; inform about the resolutions by the Board of Directors on national matters; and encourage Internet user participation in the Delegation, as well as in the political and social matters at regional and national level.*
