AGEIA DENSI Argentina (Study and Academic Research Group on Law, Economy, Business and the Information Society Association) is a non-profit Civil Association, founded in Cordoba, Argentina, and made up of young professionals and university students with specialties in Law, Economy and New Technologies, within the framework of the Information Society, is essentially multi-disciplinary (different involved disciplines: judicial, technical, communications, etc.).

Among our objectives, AGEIA DENSI is particularly involved with the interests of the final Internet users, for which the participation in ICANN has been a priority from the start of our organization and in all the stratum of discussion (LACRALO, ALAC, NCUC, etc.), as well as in the different discussion Forums related to the Governance of the Internet.

In order to achieve this proposed participation, it was necessary to train ourselves beforehand, and then train our local community, with these important principles in mind: Capacity Building, Empowerment and Outreach. We achieved this with the help of the LEBIS Department (or acronym DENSI in Spanish), which stands for Law, Economy, Business and Information Society, from the National Law University of Cordoba; and through different events in which we participate, at the local and international levels.
